

## BC HYDRO SOUP CONTEST

### OFFICIAL CONTEST RULES

#### NO PURCHASE REQUIRED

1. **CONTEST PERIOD:** British Columbia Hydro and Power Authority (“BC Hydro”) safety contest (the “Contest”) begins on February 5, 2026, at 8:00 a.m. Pacific Time (“PT”) and ends on February 28, 2026 at 11:59 p.m. PT (the “Contest Period”).
2. **ELIGIBILITY:** The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “Contest Rules”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.
3. **HOW TO ENTER: NO PURCHASE REQUIRED.** To enter for a chance to win, complete the following steps during the Contest Period:

5. **WINNER SELECTION:** A random draw will be conducted on March 2, 2026.
6. **WINNER NOTIFICATION:** Before being declared a winner, BC Hydro will contact the selected entrant via the e-mail address used by that selected entrant to submit a Contest entry. Once BC Hydro has contacted the selected entrant by email, the selected entrant is required to (a) correctly answer a time-limited mathematical skill-testing question without mechanical or other assistance and (b) sign and return Declaration, Consent, and Release form which confirms compliance with these Contest Rules, acknowledges acceptance of the prize was awarded, and releases BC Hydro from any and all liability in connection with this Contest and the prize. BC Hydro will make at least three (3) attempts over the ten (10) days following the draw to contact the selected entrant.
