BC HYDRO HOLIDAY GIFT GIVEAWAY CONTEST 2024

OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") Holiday Gift Giveaway Contest 2024 (the "Contest") begins on December 13, 2024 at 4:00 p.m. Pacific Time ("PT") and ends on December 22, 2024 at 11:59 p.m. PT (the "Contest Period").

2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the "Contest Rules"). All Contest entries must be received by the end of the Contest Period. Before being declared a winner, the selected entrant will be contacted via their social media account and be required to send their name, address, email and phone number. Once contact information is provided, BC Hydro will contact the selected entrant who will be required to, (a) correctly answer a mathematical skill-testing question and (b) sign and return a Declaration, Consent and Release form in order to receive the prize.
